- 07/07/12: Severe thunderstorm upstream of Diversion Dam caused debris from forest fire to come down river causing problems for about 3 days. Screen continued to run.
- 08/23/12: Shut down and drained screen to replace 1 brush on cleaning arm and started back up.
- 10/31/12: Shut Fish Screen down for the season.
